Estero Bay Aquatic Preserve at Risk

From Anina Bachrach:

The 13,800-acre Estero Bay Aquatic Preserve bordered on the west by islands like Lovers Key State Park and to the east by mangroves along the mainland—was purchased and protected from development many years ago. Estero Bay became the first designated aquatic preserve in 1966. Now it is under threat. SB 1210, Estero Bay Aquatic Preserve, by Sen. Martin (R-Ft. Myers) (House companion HB 057 by Rep. Botana (R-Bonita Springs)) revises the boundaries of the Estero Bay Aquatic Preserve to allow a portion of the Estero Bay Aquatic Preserve to be opened up to dredging for a 300- slip marina proposed for that location. This is an egregious violation of the local conservation efforts that put this important ecosystem under protection decades ago. Audubon is working for a more protective outcome.

From the Florida Trident:

Florida Rep. Dan Daley rips North Springs water district for its "flat out disregard for the law." December 21, 2023 By Bob Norman Days after the Florida Auditor General found the North Springs Improvement District had violated state laws and stymied competition while it handed out millions in public contracts, Florida Rep. Dan Daley (D-Coral Springs) has slammed the district for what he called "commonplace" disregard for the law. Daley excoriated NSID management for failing to obtain building permits for construction projects in Coral Springs, where, along with Parkland, the district supplies about 40,000 residents with water and sewer service. "It has come to our office's attention that NSID is once again flagrantly disregarding state and local law," Daley wrote in the letter addressed to board president Vincent Moretti. "This time in the context of local state building and permitting requirements. I would be shocked if this sort of behavior was not already so commonplace in the district."

In Case You Missed It: Governor Ron DeSantis Awards Nearly \$10 Million for Innovative Technologies to Combat Harmful Algal Blooms TALLAHASSEE, Fla. On January 11, 2024, Governor Ron DeSantis announced nearly \$10 million for innovative

technologies to combat harmful algal blooms. Funding is being provided for 10 projects that will mitigate the effects and impacts of harmful algal blooms, including blue-green algae. Harmful algal blooms impact beaches and waterways when there are excessive nutrients present, and can produce toxins that harm fish, mammals and people.
